### The 4 Charges

- 1. Protect public education as an institution
- 2. Be the voice for all marginalized populations
- 3. Stand up and stand down as appropriate
- 4. Build capacity across likeminded communities



### Protect Public Education as an Institution

There is a trend in society to erode the foundations of industrial-era institutions without understanding their value or making the effort to evolve these foundations of society to bring what is still relevant in the digital age. As a cornerstone of a free democratic society, public education is one such institution under attack. In order to continue to ensure that each successive generation is prepared to inherit the future whatever that may look like. The rights and protections afforded by the institution of public education at the federal, state and local levels come with a price tag that should be seen as an investment in our way of life and a promise for future prosperity. For these reasons, educators must be a unified voice advocating for the protection of public education so that it is not dismantled or rendered irrelevant by any interest group.





### Be the Voice for All Marginalized Populations

Especially in the last century, laws, policies and agencies have been instituted to ensure that all citizens have the right to a free, quality education in the least restrictive environment for each child. These protections include individualized education plans where appropriate, processes and procedural safeguards that protect individuals from discriminatory practices that prevent them from receiving their education, assessments and evaluations that monitor progress over time, the creation of offices and agencies to administer and enforce these programs, and the oversight of local, state and federal governments in maintaining them. As educators, we are the frontline advocates not only for these safeguards, but for the students who benefit from them, particularly those populations who identify as having special needs and considerations to ensure their access to educational opportunities. These safeguards must not be reduced or removed.



### **Communities**

This is not work that can be done in silos by isolated special interest groups. All supporters of public education are in this effort together. Begin by bringing together stakeholders within your own local sphere of influence, and then branch out to connect with other interested groups forming at the state, national and global levels who can help you provide a broader, deeper reach as you continue to elevate your message and amplify your voice to reach the decisionmakers who hold the laws, policies and purse strings for public education, from your local education agency, to your state office of public education, the federal department of education, congress, the courts and the executive branch. We do not need to worry about any specific group's turf or seniority or power in the work; it is our collective efficacy that will make the difference in protecting and promoting public education for the future.

### Stand Up and Stand Down as Appropriate

Pushing back against attempts to undermine and dismantle public education does not require educators to be openly aggressive or antagonistic. If anything, we must find common ground and build consensus among all stakeholders around what is best for children. That having been said, we can be powerful advocates on behalf of our profession by choosing not to engage in practices that damage public education, to speak and write publicly on behalf of the institution, and to organize with likeminded stakeholders to increase our influence and impact. There is increased capacity in the numbers of people we bring together to actively advocate for public schools and the agencies, legislation, policies, funding and practices that allow them to prepare students to be engaged, contributing citizens as adults. We can no longer afford to simply put our heads down and do the work. We need to thoughtfully and deliberately be a proactive force for all that is right and good about a free quality public education for all.



### Action Steps

Attend School Board Meetings

Get on the agenda and be prepared to speak for the needs and rights of all children and their families in your community, including staffing, funding and implementation of programs that ensure that all students are heard and valued and given a free and appropriate education.

Social Media Campaigns

Use our media kit to help you bring together education stakeholders on the platform of your choice and message and lead discussions on what is at stake and how they can begin to take action to advocate for the protection and fortification of public education at all levels in our society.





Letter Writing and Phone Calls

Organize efforts to contact local, state and federal policymakers and elected representatives and advocate for the protection of the institution of public education through the robust administration of its programs, policies and funding to provide for the needs of each child in each classroom in every community.

Hold a Local Town Hall

Identify your core group of local EDInfluencers and bring them together in a public forum where everyone can discuss how to organize, what you want to accomplish for your community's schools, and the next steps to begin the work and accomplish your goals. Schedule a second meeting before you adjourn.
